DISPEL: A power cleaner that removes black mould and mildew stains quickly and effectively from tile grouting, mastic and plastic shower curtains and in poor ventilated bathroom areas within the leisure and hospitality markets.

HOW TO USE

MAGIC DISPEL is used directly from the bottle as a ready to go solution and requires no dilution with water.

- Utilising the foaming trigger head spray the affected area from approximately 30 cm to allow the product to cling to vertical surfaces.
- In hotel room cleaning, housekeepers should treat mould removal as one of the first cleaning tasks to maximise the contact time whilst cleaning other areas. Rinse off with water after cleaning.
- Leave the product in contact with the surface for as long as possible before wiping and/or rinsing away. Some ingrained mould or mildew staining may require more than one application.

- Contains a bleaching agent so care must be taken not to use the product within the bedroom and avoid contact with fabric or clothing, unpainted surfaces, lightly glazed/unglazed tiles, coloured grouts or damaged enamel surfaces.
Caution: Never use this product in conjunction with an acid based product it may produce chlorine gases which can be fatal if inhaled.
